2023 allergist compensation gains outstrip inflation

Here's the latest compensation data for allergists.

We have good news for allergists: allergist median academic compensation and non-academic compensation both saw increases in 2023 - and both benchmarks rose more than the reported 3.4% rate of inflation.

The College appreciates our partnership with MGMA, which enables us to collect and report allergy-specific provider compensation data. We are particularly grateful to allergy practices (and multi-specialty practices with allergists) that

took the time to participate in the Provider Compensation survey and made it possible for the College to report this important information.

Allergist/immunologist MGMA survey participation

Allergist/immunologist participation in the MGMA Provider Compensation Survey increased 12.8% in 2024, in conjunction with the rollout of MGMA's easier survey Continued on page 9

methodology (practices can simply upload financial reports to MGMA and avoid all data entry). Compensation data was collected for a total of 680 allergists/immunologists - the most ever reported.

A total of 475 non-academic allergists/immunologists participated in the 2024 survey (which is based on 2023 data), a 12.0% increase over 2023. Participation among academic allergists increased 14.5% to the highest amount ever: 205. Additionally, allergists from across the country participated in the survey this year, with a generally even mix across all four geographic sections (eastern, midwest, southern and western).

For full-time physicians, the **median non-academic total compensation** (including provider wages, bonus/ incentive payments, research stipends, honoraria and profit distributions) for 2023 was \$351,757 when allergy/ immunology (A/I) and pediatrics A/I were combined. This was an increase over 2023 and continued an upward trend from 2019 (which was pre-COVID). 2023 median work relative value units (wRVUs), which measure physician productivity, decreased from its high in 2022 to 4,778, but still represents a substantial increase over pre-COVID levels in 2019.

Last year we began reporting a new data point for non-academic allergists: the Compensation to wRVU ratio. In 2023, this number declined to \$74.98 from the prior year. This data is important to many employed allergists since it is common in compensation formulas. Note: this is not the same as dividing median total compensation by median wRVUs. Since there are different numbers of allergists reporting compensation and wRVUs, this is not an apples-toapples comparison. For more information on the relationship between total compensation, wRVUs and the ratio of compensation to wRVUs, we encourage you to explore the College's RVU toolkit at college.acaai.org/rvutoolkit.

Median academic total compensation for the combined A/I and pediatrics A/I in 2023 was \$214,788, an increase over both the prior year and 2019 (pre-COVID). Median academic wRVUs of 3,032 increased slightly over the prior year to the highest level we've reported yet - but note wRVU data was only collected for 31 academic allergists. We are not reporting the Compensation to wRVU ratio for academic allergists because there is limited data for this statistic.

For comparison purposes, Medscape's 2023 allergist compensation data (reported in 2024) showed average A/I compensation of \$307,000, with data from less than 70 allergists. Medscape's survey does not break out academic vs. non-academic compensation, and it uses **average** compensation instead of **median** compensation; the median is typically a better representation for salary data. For all these reasons, it is difficult to rely on the Medscape data.

MGMA reported 2023 A/I total compensation by ownership type for non-academic practices, and we've observed some interesting trends over the last few years. Median compensation for physician-owned practices dipped for the second consecutive year to \$356,394 in 2023. Median compensation for hospital/integrated delivery system (IDS) owned practices, however, has increased over the past several years to \$347,407 in 2023.

Key takeaway: the gap in median compensation by ownership type has narrowed significantly, with physicianowned practices earning only 2.6% more than hospital/IDSowned practices in 2023. Historically, median compensation for physician-owned practices has consistently exceeded that for hospital/IDS-owned practices by double digits.

Another key takeaway: for the second year in a row, wRVUs for hospital/IDS-owned practices significantly exceeded wRVUs for physician-owned practices. In 2023 the difference was 13.7%. This is a reversal of the previous several years, when physician-owned practice wRVUs exceeded hospital/ IDS wRVUs. One caveat, however, is that the number of reported wRVUs in 2023 for both groups was down over previous years, which may be skewing the results.

An additional interesting observation: for the past three years, the reported number of allergists working for hospital/ IDS-owned practices has exceeded the reported number of allergists working for physician-owned practices. This is consistent with the overall trend of increased employment among allergists. Finally, a third ownership category has emerged: Other Majority Owner, which includes allergists employed by an insurance company, HMO, the government, private equity, or a university/medical school. 48 allergists, or 14% of those reporting, were in that category in 2023.

For practices planning to hire a new allergist this year, a total of 31 allergists reported 2023 starting salary guaranteed compensation data in MGMA's Provider Placement Starting Salary survey. 27 of those reporting were non-academic allergists, and four were academic allergists.

Please help us continue to provide this important data for allergy and immunology practices by participating in MGMA's surveys in 2025. Participating practices get free, direct access to the survey results (versus the limited data we can report here), and all survey data is completely confidential. Participating really is easier than ever; simply upload your reports to MGMA and you're done! "The process was very easy. I downloaded a couple of reports from Quickbooks, removed the physician's name from the report, and emailed the report to the MGMA team," said Jean Owen, MBA, vice chair of the Practice Management Committee.



New College campaign raises awareness of type 2 inflammation

In August, the College launched a project to raise awareness among primary care practitioners about type 2 inflammation and the allergic conditions related to this type of immune response. A special microsite was developed with support from Sanofi and Regeneron, targeted to primary care physicians and advanced practice nurses as well as patients/parents dealing with more than one allergic condition. The project has been overseen by Drs. Todd Mahr and Michael Blaiss, with additional subject matter expertise provided by Drs. Justin Greiwe, Benjamin Prince, Maureen Petersen and J. Wesley Sublett.

The microsite, Type2Connection.org, includes a robust collection of unique collateral developed by our experts in conjunction with our health communication pros. It addresses type 2 inflammation; the atopic march; and the individual conditions that can be caused by type 2 inflammation, which often co-occur-- atopic dermatitis; allergic rhinitis; asthma; CRSwNP; food allergy; and EoE. It includes narrative information; charts depicting controlled vs. uncontrolled conditions; a symptom checklist; and interactive graphics depicting the spectrum of conditions and the inflammatory cascade. The site also contains a special episode of the AllergyTalk podcast on this topic, plus a slide deck for physicians.

A patient page includes two excellent animated videos depicting the adult and pediatric patient journey with multiple Type 2 conditions, culminating in EoE.

Throughout the site and the campaign ads, board-certified allergists are highlighted as important specialists in treating these patients, and links to the College's Find an Allergist tool are prominently displayed on the microsite and in the ads.

Promotion will include a digital ad campaign targeting primary care physicians and nurses, patients and caregivers; inserts and ads in physician publications; and outreach via trade media and social media. There is a toolkit for allergists to use for reaching out to primary care colleagues as well. Stop by the College Resource Center booth to learn more about this campaign and how you can participate!

The Gold Headed Cane Award is given annually to a College Fellow who has demonstrated the highest standards of scientific excellence and integrity. This year, College Fellows selected Luz S. Fonacier, MD, FACAAI. The award will be presented during the Opening Ceremony and Welcome Announcements at the ACAAI 2024 Annual Scientific Meeting on Saturday, Oct. 26.

Biography provided by Dr. Fonacier

"It has been the honor of a lifetime to be selected to

receive the ACAAI Gold Headed Cane Award. I am Professor of Medicine, Head of Allergy/ Immunology and Training Program Director at the New York University Grossman School of Medicine-Long Island (currently a World Allergy Organization [WAO] Center of Excellence). I graduated Cum Laude from the University of the Philippines, then completed residencies in Dermatology and Internal Medicine. I completed two fellowships - one in Allergy and Immunology at New York Hospital-Cornell and another in Dermal Immunology at NYU Medical Center.

In 1993, I became a Fellow of the College and since 2006 have been an active member of the ACAAI Board of Regents. In 2020, I became the fourth female and the first Asian American to be selected to serve as College president. While serving as ACAAI president, I was also named chair of the American Board of Allergy and Immunology (ABAI), becoming the first person to take on both roles at the same time. I continue to be a member of the ABAI Test Writing Committee.

Involvement in the College committees allowed me to learn the intricacies of a major national organization. I chaired seven committees (Dermatological Allergy, Women's Involvement, Credentials, Workshop, Finance/Budget, International and Nominating Committees) and additionally served as a member of 10 committees (Annual Meeting Program, Continuing Medical Education, Publications, Training Program Directors' Planning, International, Occupational Health, Advocacy Council, Board of Trustees, Foundation, Archives and Membership Committees).

I received the Presidential Award of the Asian Pacific Association of Allergy and Clinical Immunology and had the honor of presenting the ACAAI Edward J. O'Connell Lectureship, John P. McGovern Lectureship, and Jean A. Chapman Memorial Lectureship.

I have participated and chaired workgroups that curated numerous informational and educational resources, developed guidelines and updates on critical allergy and immunology issues, chaired the Work Group on Update on Contact Dermatitis Practice Parameter; the Practice Improvement/CME activity on Atopic Dermatitis; the Workgroup on Atopic Dermatitis Shared Decision Making Tool; the GA²LEN/ACARE/EAACI/APAACI/AAAAI/ACAAI HAEi project to establish a global consensus on angioedema and the 2024 GA²LEN Global Urticaria Forum. I was a member of the American Board of Medical Specialties (ABMS)/ABAI/AMA-convened Physician Consortium for Performance Improvement[®] Atopic Dermatitis Work Group; the AAAAI-ACAAI Joint Task Force on Quality Measures, Urticaria measure development workgroup; and represented the ACAAI to the National Advisory Allergy and Infectious Disease Council.

Beyond the College, I was a founding member and president of the International Association of Filipino Allergists and Immunologists, and past president of the Long Island Allergy Society. I am the current chair of the WAO Skin Allergy-Atopic Dermatitis and Eczema Committee. I believe there is no better way to give the best care to our patients than to use leadership and mentorship positions to advance professional knowledge and skills and to be intimately immersed in the activities of the College. The College allows me the opportunity to give back, in my own small way, to the specialty and organization that have provided me with an immeasurable amount of personal and professional fulfillment regionally, nationally and internationally. My theme as president, to "innovate, diversify and expand" will continue in all my future work in the College, for our specialty and our profession."

A journey from a grantee to a grant reviewer

The Allergists' Foundation is dedicated to improving access to allergy and asthma care by funding innovative projects under its Community Grant Program. Marcella Aquino, MD, FACAAI, was awarded a Community Grant in 2021 to lead a two-year study exploring the various risk and resource factors affecting children with asthma and atopic dermatitis (AD) in urban areas. Now

she serves on the Foundation's Grants Allocation Committee, where she helps to select projects for funding. We asked Dr. Aquino about her transition from being a grantee to becoming a grant reviewer and what advice she would give to College members who are considering applying for a Community Grant in the future.

How has your perspective on the Community Grant Program changed from being a grantee to now being a grant reviewer?

I was honored to be granted an award from the program. My research would not have been possible without it. I learned so much from the process and am currently working on data analysis for publication. I am grateful to be able to advance our understanding of the barriers faced by children with asthma and AD and their families in obtaining care.
